**ADDITIONAL MOSQUITO POOLS* INFECTED WITH WEST NILE VIRUS FOUND
IN SACRAMENTO AND YOLO COUNTIES**

--District's Ongoing Surveillance Program Continues to Detect WNV-positive Mosquito Pools

ELK GROVE, Calif., July 11, 2006 – The Sacramento-Yolo Mosquito and Vector Control District received confirmation today that three mosquito pools, one collected from the Elverta area of Sacramento County and two from Davis, California have tested positive for West Nile virus (WNV). This is the second confirmation of the virus in mosquito populations to date. In response to the West Nile virus-positive mosquito pools, the District will continue to implement its Mosquito-Borne Disease Management plan to protect public health and welfare. This plan may include ground and/or aerial treatments where virus activity has been detected. The District routinely collects and tests adult mosquitoes throughout Sacramento and Yolo Counties.

"This is similar to what we saw last year. People need to be aware of just how fast West Nile virus can amplify now that we are in the summer months," District Manager David Brown said. "With the detection of additional West Nile virus positive-mosquito pools in our area, it is extremely important that residents protect themselves by practicing the District's 7Ds. **DRAIN** any standing water that may produce mosquitoes. **DAWN** and **DUSK** are times to avoid being outdoors. These are the times when mosquitoes are most active. **DRESS** appropriately by wearing long sleeves and pants when outdoors. **DEFEND** yourself against mosquitoes by using an effective insect repellent, such as DEET, Picaridin or Oil of Lemon Eucalyptus. Make sure you follow label directions! **DOOR** and window screens should be in good working condition. This will prevent mosquitoes from entering your home. **DISTRICT** personnel are also available to address any mosquito problem you may be experiencing by calling 1-800-429-1022 or visit the District online at FIGHTtheBITE.net," Brown said.

West Nile virus

According to the Centers for Disease Control (CDC), West Nile virus (WNV) is the leading cause of arboviral encephalitis in the United States. Originally discovered in Africa in 1937, WNV was first detected in the western hemisphere in 1999 in New York City. Since then it has caused seasonal epidemics of West Nile virus fever and severe neurological disease. West Nile virus is transmitted to humans and animals through the bite of an infected mosquito. Mosquitoes become infected with WNV when they feed on infected birds. The elderly, immune-compromised and diabetics are most susceptible to illness caused by WNV.

West Nile virus activity for Sacramento and Yolo Counties: This year, **5** dead birds, **5** mosquito pools, **0** sentinel chickens, **0** equines and **0** humans have tested positive for West Nile virus to date.

**Mosquito pools: Mosquitoes are trapped and collected from the field. The collected females are then pooled together by species. Each pool contains a minimum of one to a maximum of 50 mosquitoes per pool. Each sample is tested for the presence of St. Louis encephalitis, Western Equine encephalomyelitis and West Nile viruses by TaqMan real-time polymerase chain reaction (PCR).*
