1. <u>Board Review and Consideration to Authorize the Board Meeting</u> be Conducted by Teleconference

Staff Report:

Consider finding by a majority vote under Gov. Code § 54953, subd. (e)(1)(B) that as a result of the COVID-19 emergency: (i) meeting in person would present imminent risks to the health or safety of attendees; and (ii) the meeting is authorized to be held by teleconference pursuant to Gov. Code, § 54953, subd. (e)(1)(C).

In light of the Governor's declaration that a state of emergency exists due to the incidence and spread of the novel coronavirus, and the pandemic caused by the resulting disease COVID-19, the Board should consider whether meeting in person would present imminent risks to the health or safety of meeting attendees.

The Centers for Disease Control indicates that COVID-19 is a highly transmissible virus that is spread when an infected person breathes out droplets and very small particles that contain the virus, and such droplets and particles are breathed in by other people.¹

Conducting meetings by teleconference would directly reduce the risk of transmission among meeting attendees, including members of the public and agency staff, which has the ancillary effect of reducing risk of serious illness and death as well as reducing community spread of the virus.

If the authorization to meet by teleconference is not approved by a majority vote, then the meeting will adjourn after this item and the remaining agenda items will be rescheduled to a future in-person meeting.

This authorization will be in effect for 30 days from approval.

Recommendation:

Move that the board find that, as a result of the COVID-19 emergency, meeting in person would present imminent risks to the health or safety of attendees, and the meeting should be held by teleconference as authorized by subdivision (e)(1)(C) of section 54943 of the Government Code.

This meeting was by video teleconference. Attendance was taken by Roll Call. All Trustees aside from Trustee Barker were in attendance and a quorum was present.

4. Reports to the Board

Manager's Report: General Manager Gary Goodman gave an update on West Nile virus activity noting that based on historical numbers the District should be seeing a decline in WNV activity, however the higher temperatures might prolong the peak virus season. Mr. Goodman then mentioned the current status of COVID-19 regulations and how it affects work at the District. The presentation then shifted to the status of the District financials and the upcoming audit. The State Water Resource Control Board issued a 30 day notice to add a new active ingredient to the permit. The 30 day comment period will be closing shortly and the MVCAC put in a letter of support. The AMCA requested money from the federal government to create a new aerial adulticide model and it appears that an appropriation will be included in the federal budget. The CDC awarded the AMCA with a grant for \$250,000 to expand the Best Management Practices.

Reports from District Departments: Written reports were provided in the Board packet from each department. Department supervisors gave an oral presentation and were available to answer any questions.

Lab/Surveillance: Laboratory Director, Sarah Wheeler provided an oral report in addition to her written report. Sarah noted that *Culex tarsalis* numbers have dropped but are expected to rise in the coming weeks. *Culex pipiens* numbers are tracking on the 5 year average. Sarah then gave an overview of WNV activity in the District with mosquito, dead bird, sentinel chicken and human positives. Sarah gave an overview of mosquito production from the rice field habitat and an update on *Aedes aegypti* surveillance efforts.

Ecological Management: Ecological Management Supervisor, Marty Scholl, provided an oral report in addition to his written report. Marty started the meeting thanking the local law enforcement agencies for helping the District serve pool warrants in the month of July and the current status of the pool program. He then transitioned to what the outlook of fall flooding is shaping up to be in light of the drought.

Biological Control: Fisheries Supervisor, Tony Hedley provided an oral report in addition to his written report. Tony highlighted how fish are used in the District's control program. To date 2500 sites have been planted with mosquitofish for a total of 2188 lbs of fish.

Larval and Adult Control: Program Coordinator Steve Ramos provided an oral report in addition to his written report. Steve highlighted the work being done in and around the City of Woodland to address the hotspot of virus activity that the area is experiencing. Technicians in wetland areas have been busy speaking to landowners to get a handle on who will be flooding their fields during the fall. Aerial work on both the larval and adult sides have been consistent during the season. Invasive Aedes interventions are showing a reduction in the invasive larval population as reported back from field technicians.

Public Outreach: Public Information Officer, Luz Maria Robles provided an oral report in addition to her written report. Luz gave an update on the ride-along that the Sacramento Bee participated in with Control Operations. This ended up being a very nice in-depth look at *Aedes aegypti* within our area. Luz gave an update on the events that the District has participated in this season. Luz noted that National Mosquito Awareness week earlier in the month.

5. Board Review and Approval of MOU changes between the District and Operating Engineers Local Union #3

Mr. Goodman presented this item highlighting the sections that were amended from the previous contract. A motion to pass the MOU was made by Trustee Burnett and seconded by Trustee Mooney. The vote was taken by roll call and the motion passed by the following vote: Ayes: 12, Noes: 0, Absent: 1.

6. Status of West Nile Virus Activity and District Response

Assistant Manager Samer Elkashef presented this item. Samer went over the local and statewide WNV numbers in both mosquito and dead birds. He then went on to discuss the District's response to locally detected WNV.

The Board went into closed session at 11:14am.

District Manager Gary Goodman highlighted the PAMCA visitors from Ghana and Tanzania. They both really enjoyed their visit and took back many lessons learned that they would like to apply in their programs. Mr. Goodman let the Board know of the dates of the upcoming MVCAC meeting and the MVCAC was recruiting for a Board member. Mr. Goodman gave an update on the recruitment process for the Administrative Manager and reminded the Board that the next Meeting of the Board will be on September 20th, 2022 and will be held via Zoom.

a. Manager's Report

The District's West Nile season is picking up, however still below our average numbers of virus activity. We continue to follow the Districts Mosquito Borne Disease Management Plan with enhanced surveillance and control efforts in response to positive dead birds or positive mosquito collections.

The District continues to find invasive mosquitoes in some new areas this year with the Northgate area having some of the highest numbers we've seen. Staff is conducting wide area larviciding in neighborhoods to try and lower their abundance along with intensive door to door inspections. We expect the numbers to begin to fall with the cooler weather in November but we still have a few weeks left to manage the populations.

The District has received the CalPERS valuations that highlight our unfunded liability and we have scheduled a meeting with their staff to discuss.

The District audit is scheduled to be done in October.








Weekly Culex tarsalis abundance traps in locker and gravid traps



Encephalitis virus surveillance (EVS) – The following graphs show the number of Culex tarsalis and Culex pipiens that were collected in CO_2 -baited EVS traps run in established and West Nile virus response locations for a single night, then tested for West Nile virus.




Culex tarsalis in CO2 traps

West Nile virus (WNV) testing – 4,406 mosquito pools of *Culex tarsalis* and *Culex pipie*ns were tested for WNV, 90 tested positive for WNV.

Dead birds – Overall, 296 dead birds have been collected and tested. In total 49 tested positive for WNV.




Cumulative 2022 Detections of WNV positive mosquito pools and dead birds.

Sentinel chickens – West Nile virus seroconversions were detected at two sentinel chicken flocks. At the Isleton flock one chicken tested positive for WNV antibodies on 8/11/2022 and four chickens tested positive on 8/25/2022. At the Knights Landing flock two chickens tested positive on 8/8/2022 and a third chicken tested positive on 8/22/2022. Positive chicken will be removed from the flock and replace with antibody negative chickens that were held in a mosquito-proof coop at the Bond Rd. facility. Thus far the remaining flocks in Dunnigan, Sacramento, and Rancho Murrieta have not tested positive.

Human disease response surveillance – No human cases were reported to the District for investigation during the past month. The California Department of Public Health is current reporting three human cases of WNV in Yolo County and no cases Sacramento County.

Aedes aegypti trapping effort in Sacramento and Yolo Counties - Biogents (BG) Sentinel traps are the primary trap type used for Aedes aegypti surveillance. These traps are run continuously within the cities where Aedes aegypti populations have established including: Elk Grove, Winters, and Sacramento (Arden/Arcade, Rosemont, and Elder Creek communities). BG traps are also set for a single night to detect new infestations and further define current infestations. The following table shows the cumulative 2022 BG trapping effort and Aedes aegypti detections.

ECOLOGICAL MANAGEMENT DEPARTMENT Monthly Report for the September 2022 Board Meeting

Stormwater / Wetland Program

<u>CA Department of Water Resources (DWR) Sherman and Twitchell Islands:</u> Due to the ongoing drought, DWR has been unable to keep the Delta Island wetlands flooded this season. DWR staff are preparing for anticipated future drought years and drought regulations and have requested assistance from the District to design a maintenance plan that may allow for some smaller holdings of water into next year.

<u>Sacramento County, Elder Creek:</u> Sacramento County Department of Water Resources is helping the District with removing beaver dams within Elder Creek to keep water from re-filing low areas located on higher ground adjacent to the creek.



Pool Program

Staff submitted an Inspection and Abatement Warrant for an additional eight backyard pool properties that will be served if granted before the end of the mosquito season.

Agricultural Program

Staff continue work on agricultural drainage projects around the greater Sacramento area utilizing District equipment. Staff has purchased a new swing boom brush cutter to assist with mowing brush in agricultural and wetland ditches on new and existing projects.

Cemetery Program

Staff have been inspecting and treating local cemeteries throughout the District using Watersorb crystals. The single use water soluble packets contain the correct amount of crystals to fill a cemetery


vase completely, thus preventing mosquito breeding.






Fall Flooding

Staff has contacted all wetland owners and Managers to coordinate the start of fall habitat flooding. Due to drought conditions, a limited number of fields will be flooded prior to October 1st, with the majority of early flooding on Vic Fazio Wildlife Area, and the Cosumnes River Preserve.





BIOLOGICAL CONTROL Monthly Report for September 2022 Board Meeting

In the month of August the Districts rice field stocking program came to a close with a total of 2306 pounds of mosquitofish used in 146 different rice fields in the most densely populated areas of our counties. Fisheries staff began to prepare for wetland flooding. This consists of contacting land management owners and or working closely with field personnel for sensitive habitats and flood up schedules. We are expecting to use approximately 400-800 more pounds of fish for these fall flood up fish plants. The main areas of focus will be the Vic Fazio Yolo Wildlife Area, Cosumnes River Preserve and the Stone Lakes National Wildlife Refuge. In addition to these wildlife wetlands Sacramento and Yolo Counties have many re-flooded rice fields to serve as waterfowl habitat. Additional activities include pond rehab. This consists of draining down designated ponds, harvesting every fish possible, moving rock and then removing loose debris. The department also continued to gather weekly data for all of our ongoing projects crayfish control and the use of solar aerators on dissolved oxygen levels. Daily activities such as medical treatments and tank cleaning were also performed to maintain the high quality of our fish population.

CONTROL OPERATIONS Monthly Report for September 2022 Board Meeting

Culex and West Nile Virus (WNV) Control

The month of August had an increase in mosquito samples that tested positive for WNV. Field technicians have been responding to positive samples by re-inspecting sources in a radius of up to 1 mile around positive mosquito samples. Along with radius work, the Catch Basin crew has been re-inspecting basins for breeding and efficacy of product. Technicians have also been performing ground ULV treatments in the immediate area of positive mosquito samples utilizing truck, ATV and backpack ULV applications.

Aerial Applications


Similar to years past, August was the busiest month for WNV and abundance response with aerial adulticide treatments over rice growing areas. August accounts for over 50% of acres treated aerially out of the season. As we move into September, rice fields are now beginning to drain and preparing for harvest, which can create a surge in adult mosquitoes in the area as harborage is removed. Rice field aerial larvicide treatments will still be performed on fields holding water until they begin to drain, while partially water filled fields will be treated by drone or by the field technicians.

Invasive Aedes Control

New detections of *Aedes aegypti* were discovered in August in the Rio Linda area and in the North Gate area of South Natomas. WALS treatments combined with ground ULV adulticide treatments are ongoing in the South Sacramento area of Elder Creek and in the North Gate detection area. The Rio Linda response has been focused on ground crew inspections and treatments. Trapping will continue through the season around these areas to outline a perimeter of the affected areas.

District Trials

The District continues trial work evaluating the efficacy of products in yard drain and basin environments both here on the District property and out in the field. The ongoing trials are measuring the effectiveness and longevity of both Spinosad and BTI products designed for these types of breeding habitats. Aerial adulticide and larvicide trials have concluded for the season and the data collected will be evaluated for possible state and national presentations that are upcoming.

PUBLIC INFORMATION AND EDUCATION Monthly Report for the September 2022 Board Meeting

Invasive Mosquitoes

Upon the detection of invasive mosquitoes in a new area along Northgate Blvd and the south Natomas area in the city of Sacramento, a press release was sent out. That same day we had a segment on Studio 40 on the local KTXL Fox 40 television station where we discussed invasive mosquitoes as the newest challenge since these mosquitoes have been rapidly spreading throughout the region. Immediately after the new detections, District staff began their door to door inspections looking for mosquito breeding sources and talking to residents about mitigation measures in their backyards.

Currently a postcard is being developed to be mailed to residents in affected neighborhoods in the new detection sites.

Advertising Campaign

The advertising campaign continues to be in full swing and our Fight the Bite messages are airing consistently across radio and television stations. Currently we are airing content specific to invasive mosquitoes due to new and ongoing detections. The media schedule is in flights so that our messages are being rotated across stations and this ensures a constant presence at all times throughout the media market. The advertising campaign will continue thru the second week in October.

Events:

The month of September is a very busy month with community outreach events. Immediately after the new invasive *Aedes* detection, we attended an event called Chalk it Up Natomas where we were able to speak to residents directly. Luckily many of the people stopping by the booth had heard about the invasive mosquitoes and our response control treatment via social media. At this event we were also able to connect with local neighborhood associations, the rotary club and local media outlet N Magazine. Due to these connections we will also be attending another upcoming event in Natomas called POPS in the Park which is an outdoor evening concert.

Another large event this month is Farm to Fork. This is one of the biggest and most successful events that we participate in throughout the season. This very popular event takes place in downtown Sacramento and draws thousands of attendee's. It is a great event because we're able to reach out to a wide and very ethnically diverse audience that is interested in our program. Other events where we will have a presence include Independence Day at the capitol which attracts more than 5,000. This popular event takes place in the evening, so the repellent packets are very much appreciated and useful. In September we will also be attending the Carnitas Festival in Winters where we'll be able to talk to residents about the invasive mosquito infestation throughout the city and Sunday Funday in Citrus Heights.

Social media

After the initial detection of invasive mosquitoes along Northgate Blvd and south Natomas, field staff began door to door outreach in affected neighborhoods. Technicians utilized the door

hanger along with a public relations bag that was left at all home that also included an informational brochure, a magnetic business card, repellent wipes and a pen.

Social media messages specific to invasive *Aedes* mosquitoes are being posted on all platforms along with Facebook posts that are boosted and targeted specifically to residents located within the detection areas. In addition, we are using Nextdoor to post specific messages regarding the invasive mosquito findings and including photos of backyard sources, District staff knocking on doors and interacting with residents.

Repellent Distribution

We have recently provided repellent wipes to Harm Reduction Services, an agency that provides services to homeless residents and a Galt Boy Scouts troop. Upon the detection of invasive mosquitoes in the city of Sacramento we also reached out to the council district and offered repellent for upcoming outdoor events such as movies or concerts in the park.

Government affairs:

As part of our ongoing detection of invasive mosquitoes as well as WNV activity, we have been keeping local elected officials informed by sending them regular email updates with our findings and response activities.

Presentations:

A presentation is currently scheduled to the Winters Kiwanis Club on September 26th and we will be reaching out to the Natomas Rotary club to schedule speaking opportunities in the near future.
